ANANTHAKRISHNAN G. New Delhi, September 6

THE SUPREME COURT on Wednesday asked the Manipur government to act against illegal weapons, irrespective of the affiliation of those stocking or using them, and sought a status report on its August 7 direction to take stock of weapons looted or missing and formulate a plan to recover them.

CJI D Y Chandrachud, presiding over a three-judge bench that took up petitions filed in the wake of ethnic clashes in the state, told the counsel for various tribal communities who accused each other of looting weapons and using them in the conflict, "...we are not concerned with who looted. We are looking at it as we have said repeatedly that we are not concerned with the source of the wrongdoing."

He said: "We are concerned with the fact that there has to be accountability for wrong doing. We are not concerned with



Slapping of student: SC seeks report on probe, issues notice

THE SUPREME COURT Wednesday asked the Muzaffarnagar Police for a status report on the investigation into the slapping of a seven-yearold boy by fellow students on the instructions of their teacher. The teacher, Tripta Tyagi (60), had referred to the boy's faith and spoken pejoratively about "Mohammedan children" as she asked other students to beat the boy "hard". The boy's family said he was beaten up for a mistake in multiplication tables.

Issuing notice to the Uttar Pradesh government on a plea filed by activist Tushar Gandhi, a bench of Justices A S Oka and Pankaj Mithal asked the Muzaffarnagar Superintendent of Police to inform it about the steps taken for the security of the boy and his family. The plea also seeks guidelines regarding preventive and remedial measures within the school system to prevent violence against children, including those belonging to religious minorities.

CJI D Y Chandrachud, presiding over a three-judge bench that took up petitions filed in the wake of ethnic clashes in the state, told the counsel for various tribal communities who accused each other of looting weapons and using them in the conflict, "...we are not concerned with who looted. We are looking at it as we have said repeatedly that we are not concerned with the source of the wrongdoing."

APEX COURT SEEKS 'ACCOUNTABILITY FOR WRONGDOING'

SC asks Manipur to act against illegal weapons

ANANTHAKRISHNAN G. New Delhi, September 6

THE SUPREME COURT on Wednesday asked the Manipur government to act against illegalweapons, irrespective of the affiliation of those stocking or using them, and sought a status report on its August 7 direction to take stock of weapons looted or missing and formulate a plan to recover them.

CJI D Y Chandrachud, presiding over a three-judge bench that took up petitions filed in the wake of ethnic clashes in the state, told the counsel for various tribal communities who accused each other of looting weapons and using them in the conflict, "...we are not concerned with who looted. We are looking at it as we have said repeatedly that we are not concerned with the source of the wrongdoing."

He said: "We are concerned with the fact that there has to be accountability for wrong doing. We are not concerned with

The BJP on August 17 announced its candidates for 39 seats of the total 230 seats in Madhya Pradesh and 21 of 90 seats in Chhattisgarh three months before Assembly elections in the two states, naming the candidates only in seats which it had lost in the 2018 polls. The declaration of early candidates has exposed gaps in the EC's poll expenditure monitoring rules that stipulate accounting of candidates' spending from the date of their nomination and not even announcement of the polls, which is expected in these states in October.

During its current visit to Bhopal, the three-member Election Commission of India was on Monday urged by the Congress to include the expenditure incurred by the 39 BJP candidates before the official start of the election period in their account.

The Congress also alleged that Madhya Pradesh Chief Minister Shivraj Singh Chouhan was campaigning in support of these candidates on government expenses and misusing the state machinery, which is not allowed when the Model Code of Conduct (MCC) is in force with the announcement of the election schedule.

On August 21, BRS in Telangana also announced candidates for 115 of the state's total 119 Assembly constituencies. Retaining all his ministers and senior MLAs as candidates, CM BRS supremo K Chadrashekar Rao or KCR declared he will contest from two seats.

According to Section 77 (1) of the Representation of the People Act, 1951, candidates are expected to keep an account of expenditure incurred on the elections from the "date on which he has been nominated" till the "date of declaration of the result". The EC's former legal advi-

sor S K Mendiratta said Section 77 (1) of the RP Act was amended in 1974 to provide that expenditure of a candidate is accounted from the date of filing nomination with the Returning Office. This, he said, was done in the context of the election petition against Indira Gandhi that was then pending before the Allahabad High Court.

"Prior to that, the expenditure was counted from the date the candidate declared himself as a candidate, but that was a vague provision as no definite date was prescribed in law," Mendiratta said.
